Alexander Cameron Rutherford B.A., B.C.L., LL.D.

INTRODUCTION

Alexander Cameron Rutherford was born in Osgoode, Carleton County, Ontario, on February 2, 1857. His parents emigrated to Canada from Aberfeldy, Scotland in 1855. Educated in Ontario's public schools, and Woodstock College, he taught school for a year and then attended McGill University in Montreal where he graduated with a B.A. and B.C.L. in 1881. He articled with Sir Richard Scott in Ottawa, was admitted to the Bar of Ontario in 1885 and immediately went into the partnership of Hodgins, Kidd and Rutherford with offices in Ottawa and Kempville.

In 1888 he married M. Birkett and two children, Cecil, and Hazel, were born to them. He came west to Strathcona, N.W.T., and was elected to the North West Territories Assembly 1902-05. During this period he was Deputy Speaker. In 1905, he was called to lead the first government of Alberta. Dr. Rutherford also held the portfolios of Previncial Treasurer and Minister of Education. He introduced, in 1906, a bill which founded the University of Alberta. In recognition of his efforts to establish higher education in the new prairie province, the University of Toronto awarded him an LL.D. In 1907.

Although Dr. Rutherford resigned as Premier in 1910, he continued to take an interest in the University. He was elected its Chancellor in 1927 and continued in that position until his dealth on June 12, 1941.

In 1950, through the generosity of his children, the Universtry acquired Dr. Rutherford's Canadiana Library and his surviving private papers. The papers are, with a few exceptions, incoming correspondence and deal with the years he was Premier of Alberta.

At the request of the family Dr. Rutherford's papers are open for research.

COMMENTARY

Before becoming Premier of Alberta in 1905, Alexander Cameron Rutherford had held public office in the new town of Strathcona and had served as MLA in the Assembly of the N.W.T. at Regina. A small collection of letters received in his various capacities passed to his son, Cecil, (1891 - 1957) whose widow eventually transferred them to the care of the Provincial Archives. Mrs. Rutherford retained four items which were of special interest to her:

- 1. Holograph letter from Father Lacombe requesting support for an orphanage
- 2. Autograph letter from Lord Strathcona introducing a Dr. John Gunn
- 3. Holograph letter from Sir F. W. G. Haultain of Regina requesting that sessional papers, reports statues, estimates, and public accounts be sent to him from time to time, 24th March, 1910
- 4. Copy of reply by A.C.R. to Haultain, 26th March, 1910

Xerox copies of all the letters were placed in the Archives of the Glenbow-Alberta Institute in 1966 (reference A.R975). Among the Xerox copies is a letter from Sir Wilfrid Laurier concerning the Athabasca Railway 26th March 1907. The original has not been found.

COMMENTARY

A.C. Rutherford (1858-1941) was born, raised, and educated in eastern Canada. In 1895 he moved west to Strathcona, Alberta to practise law. He was active in local politics serving as secretary of the school board, and as treasurer and solicitor for the Town of Strathcona. During the years 1902-1905 he represented Strathcona on the Council of the North-west Territories. When the province of Alberta was created in 1905, he served as the first Premier, Provincial Treasurer, and Minister of Education. In 1910 A.C. Rutherford left office, and in 1913 gave up his seat in the House. From 1927 until his death in 1941 he served as Chancellor of the University of Alberta.

The material in this collection was donated by Mrs. Hazel McCuaig, daughter of Dr. and Mrs. A.C. Rutherford.
