I have, in some cases, made assumptions about who was being mentioned or what legislation was being discussed. I have also had to decide between different names used to refer to a single entity. I have done my best to discover the correct names and terms by checking other references but if any serious errors are found, just let us know what the correction should be and we will provide a corrected index.

Assuming that there will be a future revision after another round of interviews, if there is any elaboration (full names where I now have blanks, etc.) or minor corrections which could be left until the revision, you can give them to me at any time and I will keep them on file until we begin work on the revision.

In most cases I have copied the accepted name of each Act from the Alberta Statutes. Only in the case of the Eastern Slopes Act did I abandon that practice entirely because the name is far too long to use in an index. The Acts of Agreements between the Dominion and the Province have been shortened slightly.

You may find some minor oddities in the sorting sequence. We are working in a new programming language and our new sort program doesn't yet come to grips with all the variations in the use of commas, parentheses, etc.
