Sent to McGill University on full pay by Government of Canada (1954-55) to attend Institute of International Air Law (now Institute of Air and Space Law); at same time, studied general International Law, and took special Seminar on Law and the United Nations.

Special study of activities of National War Labour Board with extensive involvement in statistics.

Combines and Monopolies:

Dealt with variety of matters while with Combines Investigation Branch in Government of Canada. Highlight was assignment for two and a half years in Calgary, Alberta, to assist special Crown Prosecutors C.S. Blanchard, Q.C. and Mr. (now Mr. Justice) H.W. Riley in the difficult Western Bread Prosecution (1949-51). The case was successful in reversing the legal situation established in the West some years before by the loss of the Imperial Tobacco Prosecution. The Western Bread Case was a landmark in a number of areas of jurisprudence. It

provided permanently valuable knowledge about the ways of dealing with matters of the most complex and detailed kind.

Work in the Department of Justice:

As a result of the work done on the Western Bread Case, was invited to enter the legal division of the Department of Justice. Worked closely with the then Deputy Minister, Mr. F.P. Varcoe, Q.C. on a wide variety of matters. Experience included:

A. The United Nations and International Law

- including such subjects as the following:
- International Covenants on Human Rights, including legal, constitutional and political problems in Canada and abroad.
- Federal State Clauses and Federal State Reservations to Treaties and other International documents signed and ratified or acceded to by the Government of Canada.
- Problems relating to Crimes aboard Aircraft (Awarded LL.M. by McGill University for an in-depth thesis on this subject.)
- Air Law questions, including problems under Warsaw Convention.

- Reference by the Federal Government to the Supreme Court of Canada in 1967 on complex questions of rights over offshore areas of the Pacific Ocean adjacent to the coasts of British Columbia. The case was successful, and has formed the basis for Federal Government policy since that time.

Responsible for the research in International Law and Constitutional Law which formed the legal basis for this important Reference and appeared before the Supreme Court of Canada with Toronto Counsel and the Deputy Minister of Justice.

Seconded in 1957 by the then Deputy Minister of Justice Mr. W.R. Jackett, Q.C. (now the Chief Justice of the Federal Court of Canada) to the Honourable Mr. E. Davie Fulton, newly appointed Minister of Justice following the Conservative electoral success. Organized Mr. Fulton's office and the Department of Justice and the Department of Justice and the Minister's office and the Minister was responsible. Thereafter returned to legal duties in the Department of Justice.

1963 - Seconded by the then Deputy Minister of Justice Mr. E. A. Dreidger, to the Honourable Mr. Lionel Chevrier as his Executive Assistant, when Mr. Chevrier became Minister of Justice for Canada. Established procedures for co-ordinating the work of the office of the Minister of Justice with the Department of Justice and other bodies responsible to the Minister of Justice by special request of the Honourable Mr. Chevrier of Justice by special request of the Honourable Mr. Chevrier after the immediate problems of organization were completed, and remained with Mr. Chevrier in that capacity throughout the nine months he was Minister of Justice until his appointment as High Commissioner for Canada to the United Kingdom.

- Interviewing persons desiring to see the Minister and briefing the Minister on specific problems involved.
- Preparation of letters of all kinds for the Minister's signature.
- Communication with individuals and organizations on behalf of the Minister.

Returned to legal duties in the Department of Justice in 1964, when the Honourable Mr. Chevrier was appointed High Commissioner for Canada to the United Kingdom.

Present Position:

Appointed by Order-in-Council as Vice-Chairman of the Antidumping Tribunal, Ottawa, effective September 1, 1972. Assumed duties on November 1, 1972.

The Anti-dumping Tribunal is a Court of Record under Section 27(1) of the Anti-dumping Act.

As the first legal member of the Tribunal (as well as Vice-Chairman):

- Assisted in developing means of meeting legal problems resulting from major decision of the Federal Court of Appeal in the Magnasonic Case.
- Prepared memoranda dealing with legal status and powers of the Tribunal and with a variety of legal problems encountered by the Tribunal, subsequent to the resignation of the former Chairman.
- Originated and developed various rules and procedures for consideration by the Tribunal with reference to the various types of inquiries and other proceedings by the Tribunal.
- Developed methods for assisting the Tribunal in organizational problems until a permanent Secretary for the Tribunal could be appointed, including emergency arrangements for bilingual secretaries, co-ordination of transcribing, use of different colour paper for transcribing in-camera hearings to eliminate risk of accidental release of confidential material, etc.
- Devised an original Flow Chart for use by the Tribunal in planning work on Inquiries and trained personnel on keeping the Flow Chart up to date.
- Participated, as a Member of the Tribunal, from time to time, in various hearings by the Tribunal of allegations of injury to Canadian industry alleged to have resulted from dumping of foreign products. Presided as designated by the Chairman, during consideration by Members of the Tribunal of certain requests for review of finding of Tribunal in respect of Apple Juice Concentrate originating in Austria, Bulgaria, Greece, Hungary and Switzerland; and references re Photo Albums and Yeast.
